
The ABCs of Non-Traded BDCs


A non-traded business development company ("BDC") is a public, continuously offered investment product that comes with several features that can provide potential benefits for individual investors.

Non-Traded BDC Features



How a BDC Works

BDCs are structured to offer income-seeking individual investors access to the debt and equity of private or developing public companies. BDCs invest in these companies and in turn receive debt payments or earnings, and this income is then distributed to investors.



Investing in a BDC: Potential Benefits

Access to New Investment Opportunities

BDCs are structured to enable individual investors to access and invest in growing small or middle-market companies—opportunities typically only accessible to institutional investors.

High Income Potential

BDCs aim to invest in companies with high income-generating potential, and they often elect to be structured as a Regulated Investment Company ("RIC"), by which they are required to distribute 90% of annual income to investors.

Periodic Liquidity

Shares of non-traded BDCs are sold through continuous offerings, and periodic share repurchases are often available to investors at predetermined times.

Transparency

BDCs are required to value their assets quarterly and file financial reporting documents (10Q, 10K) with the SEC, giving investors a transparent view of their investments.

Simplified Tax Reporting and Tax Efficiency

BDCs issue a 1099 tax form to investors. Because they are registered funds, they can also be structured as a RIC, which generally "passes through" income to investors, thereby avoiding double taxation.

- Oaktree Strategic Credit Fund has no prior operating history and there is no assurance that it will achieve its investment objective.
- This is a "blind pool" offering and thus you will not have the opportunity to evaluate Oaktree Strategic Credit Fund's investments before it makes them.
- You should not expect to be able to sell your shares regardless of how well Oaktree Strategic Credit Fund performs.
- You should consider that you may not have access to the money you invest for an extended period of time.
- Oaktree Strategic Credit Fund does not intend to list the shares on any securities exchange, and it does not expect a secondary market in the shares to develop prior to any listing.
- Because you may be unable to sell your shares, you will be unable to reduce your exposure in any market downturn.
- Oaktree Strategic Credit Fund intends to implement a share repurchase program, but only
 a limited number of shares will be eligible for repurchase, and repurchases will be subject
 to available liquidity and other significant restrictions.

- · Oaktree Strategic Credit Fund intends to invest in securities that are rated below investment grade by rating agencies or that would be rated below investment grade if they were rated. Below-investment-grade securities, which are often referred to as "junk," have predominantly speculative characteristics with respect to the issuer's capacity to pay interest and repay principal. They may also be illiquid and difficult to value.
