Quarterly Performance Update

The **Oaktree Strategic Credit Fund** (the "Fund") reported strong performance for the first calendar quarter of 2025 amid persistent market volatility fueled by macroeconomic and geopolitical challenges. The Fund's net asset value (NAV) per share finished the first calendar quarter of 2025 at \$23.28, down slightly from \$23.52 as of December 31, 2024. The Fund's annualized distribution rate for Class I shares was 10.31% and the net return for the quarter for Class I shares was 1.54%, reflecting the portfolio's defensive positioning.

Portfolio Positioning

The Fund's all-weather approach aims to capitalize on favorable relative-value opportunities in credit across different market conditions. Our disciplined, bottom-up credit underwriting allows us to identify attractive risk-adjusted investment opportunities. Our portfolio emphasizes investments that are positioned at the top of the capital structure. As a result, we aim to enhance the stability and resilience of our investments, providing a solid foundation for long-term risk-adjusted returns.

As of March 31, 2025, the Fund:

- Made over \$1 billion in new investments, including
 11 private loan originations, in the quarter
- Had net leverage of 0.47x,⁵ positioning the Fund to go on the offensive to invest in attractive opportunities as they arise
- Was over 89%³ senior secured, demonstrating our focus on being at the top of the capital structure
- Had a 92%⁴ allocation to floating-rate debt, which we believe positions us well in an uncertain rate environment
- Was diversified across 179 issuers and more than
 35 industries, which helps to avoid being overly reliant on any particular industry for sourcing deal flow
- Had an average debt position (including unfunded commitments) of \$34.0 million and a weighted average yield on debt investments of just over 9.7%
- Had a median portfolio company EBITDA of \$188 million and loan-to-value of approximately 42%, underscoring our emphasis on investing in larger businesses with lower leverage
- Received investment grade ratings by Moody's of Baa3 and by Fitch of BBB-, underscoring our high credit quality⁶

Outlook

We believe the portfolio's construction should continue to support performance. While interest rates stabilized in the first calendar quarter of the year, they remain higher than recent historical averages and credit instruments continue to provide investors with the potential for attractive risk-adjusted returns.

Credit markets performed well in the final calendar quarter of 2024, as both public and private markets experienced a wave of repricing activity. As a result, we observed overall spreads compress throughout the year. However, momentum slowed meaningfully in the first quarter of 2025 amid increased policy uncertainty, which weighed on both public and private deal activity. If uncertainty persists, direct lenders may also encounter problem loans and higher redemption requests from their private business development companies, shrinking the supply of capital in credit markets. The longer we remain in this period of uncertainty, the more likely borrowers' financial health will deteriorate. This could drive leverage levels higher, push liquidity levels lower, and cause more borrowers to trip their debt covenants. Furthermore, borrowers with a nearterm maturity may struggle to refinance.

These crosscurrents certainly cloud our view of private credit origination, pricing and loan quality going forward. A handful of new deals have been signed over the last few weeks, and early indications point to direct lending spreads only widening by 25 to 50 basis points. Such limited widening is likely due to the lack of deal flow compounded by the fact that several of these companies have limited exposure to tariffs (e.g., domestic service businesses). At this point, these lending opportunities are well bid in a market with meaningful lending capacity. Overall, if current market conditions persist throughout 2025, fewer deals could be offset by fewer lenders which could leave supply and demand in rough balance.

In light of the above, we remain cautious in our investment approach but continue to see limited but actionable deal flow due through the strong sponsor and industry relationships that we have maintained over two decades.

Additionally, should the broadly syndicated loan market remain challenged, demand for private credit will likely increase due to an increased need for refinancing capital. We endeavor to structure future investments with the view that it is more likely that uncertainty will continue to be the realm for the short to medium term.

Against this backdrop, we believe the Fund is positioned well for both market turbulence fueled by macroeconomic and geopolitical uncertainty, as well as an uncertain interest rate environment, given the portfolio's preponderance of senior secured, primarily first lien floating-rate holdings. Oaktree has navigated through many economic cycles and gained valuable experience that has allowed us to capitalize on opportunities during more volatile markets. We believe that having ample capital, taking a long-term view, and remaining focused on navigating short-term volatility should position the Fund well to capitalize on opportunities going forward.
